Minutes of the Section Summer Board Meeting, July 1998

On Monday, July 13, 1998, at 1:00 p.m., the Subject Specialists Section's Board met at the Bluebonnet Library in Baton Rouge. Persons attending included Sherry Moore, USL, Chair of Subject Specialists; Lea Wade, UNO, Past Chair; Dixie Jones, LSUMC-Shreveport; Sandy Mooney, LSU Design Center; and Pamela Arceneaux, Historic New Orleans Collection. The need for bylaws for the Subject Specialists Section was discussed, using the bylaws of the Academic Section as a model. It was suggested that the next *Subject Specialists Newsletter* contain the text of our bylaws. Establishing a web page for the Section was discussed, as was the need to increase membership. Elements of procedures regarding the Lucy B. Foote Award were also discussed, with the suggestion made that recipients of the award should also receive a small scrapbook containing copies of the letters recommending them for the award. There was some discussion of the next LLA Conference to be held in Baton Rouge, March 1999, with emphasis on a Subject Specialists presentation featuring some technological advance. The meeting broke around 3:00 p.m.

AREA CODE CHANGE:(Per BellSouth)

Beginning August 17, 1998, telephone customers in Baton Rouge and several neighboring communities will have a new area code: **225**.

Customers will have an extended transition period before the new area code becomes mandatory. From **August 17, 1998 through April 4, 1999**, callers can use either 504 or 225 and still reach their connection. As of **April 5, 1999**, callers will be required to use the new 225 area code.

The new 225 area code will be implemented within the Baton Rouge calling zone which includes Point Coupee, West Feliciana, East Feliciana, Ascension, Iberville, West Baton Rouge, East Baton Rouge, and most of St. Helena, Livingston, and St. James parishes. Small portions of Tangipahoa, Assumption and St. John the Baptist parishes are also affected.

The new area code will create more numbers to keep up with the demand for personal computers with modems, cellular/PCS telephones, pagers, and exchanges for local and long-distance companies.

The Subject Specialists Section and the 1999 LLA Annual Conference:

The Subject Specialists Section has a number of programs in the works for the 1999 LLA Annual Conference. These are document imaging and hands-on training in Windows 95.

The Windows 95 program by Bob Bradley (LEERIC) will be a hands-on learning situation at the International Technology Center at the Louisiana School for the Deaf from 8:00 - 10:00 a.m. These are wonderful facilities. The program will be limited to 30 people. Bob presented a lecture on Windows 95 at the 1998 Conference and the room was filled to overflowing. He will be presenting a basic introduction and talking about shortcuts, transferring files, making and finding folders, etc.

With the theme of the conference being "Louisiana Libraries 2000 AT&T: Advocacy, Technology, Tradition," we thought a preservation/document imaging program would be appropriate. Many librarians are considering scanning documents but are they thinking about how to plan such a massive, expensive project? There are many workshops on the actual "doing." Faye Philips, who was closely involved in LSU's Document Imaging Project, will present a program on document imaging from a management, rather than a technical How-to-do-it viewpoint. What should management be looking at? What are the advantages and disadvantages of various imaging techniques? What are the costs in terms of money, time and labor? Should libraries wait until the costs and processes are more developed?

Actual dates during the conference for both of these programs are not yet set. The Subject Specialists

Section's Business meeting tentatively will follow one of these. Look to the LLA Webpage for more Conference Information in late November/early December.

News from the Historic New Orleans Collection

The Historic New Orleans Collection has acquired the library collection of the Ursuline Sisters of New Orleans, an extraordinary collection of rare books and library materials dating back nearly four centuries. The 1,900 books contain many unique items, including a collection of southern colonial materials believed to be the only ones in existence. According to Dr. Charles Nolan, archivist for the Archdiocese of New Orleans, "the Ursuline library collection is probably the most extensive early southern Catholic library that exists." The Ursuline Order established their community in New Orleans in 1727.

Upon completing the transfer of these important resources from the Ursuline Sisters to the Historic New Orleans Collection's research facilities at the Williams Research Center in the French Quarter, the Collection library will begin addressing the conservation and preservation needs of this collection. In addition to customized cataloging to be completed by OCLC's TECHPRO Unit, the cataloged Ursuline records will be entered into the WorldCat database (the OCLC Online Union Catalog) of nearly 38 million records, a research "first" for many of these Ursuline titles.

Community Planning. Established in 1996, the Division of Community Planning (DOCP) provides planning assistance to local governments and neighborhood based organizations in the metropolitan area of New Orleans, as well as to other Divisions within the College of Urban and Public Affairs. Their presentation will be about the recently completed project for Save Our Cemeteries, Inc. This involved the development of a picture/text database inventory of St. Louis No. 1 and Lafayette No. 1, as well as building a web site to house information about Save Our Cemeteries. Directions: The Williams Research Center is literally in the Heart of the French Quarter. The William Research Center is specifically located at 410 Chartres Street, right behind the Louisiana Supreme Court Building (formerly, the Wildlife and Fisheries Building) and we are right next door to K-Paul's Louisiana Kitchen Restaurant. In the French Quarter, Chartres Street runs parallel to Royal Street and Bourbon Street, and we are in between the cross streets, Conti Street and St. Louis Street.

Go to New Orleans. You can park under the Royal Orleans Hotel in the 500 block of Chartres Street or in one of the lots on the same block. Parking is also available at a number of lots on Decatur Street, one block over and near the Jax Brewery complex of buildings.

After the tour of the Williams Research Center, the group will walk over to the Historic New Orleans Collection complex of buildings/museum at 530 Royal Street, one block over from Chartres and one block down from St. Louis Street. We will be meeting in the Counting House Building at 530 Royal Street as well as touring the other buildings here during the rest of the day.

Menus of the many nearby restaurants and a map of the French Quarter will be available for everyone to look over in deciding where to go for lunch.

Draft Bylaws

Article 1. Name

The name of this organization shall be the Louisiana Library Association Subject Specialists Section.

Article 2. Purpose

The purpose of the Subject Specialists Section is to encourage those with a subject interest or expertise, or who are employed in a special library, information center or special collection to participate in the activities of the Section.

Article 3. Membership

Section 1. Any person who is a member of the Louisiana Library Association and who is interested in or works with special collections or subjects may become a member by designating membership in the appropriate place on the annual LLA membership form.

Section 2. Members are eligible to vote and hold office in the Section and will receive the official newsletter. Non-members may attend programs and access the newsletter via the World Wide Web but

are not eligible to vote.

Article 4. Section Officers

Section 1. Officers. The officers of the Section shall be the Chair, Vice-Chair, Chair-Elect, and Secretary. These officers compose the Section's Executive Board and shall follow the *Code for all Sections* as stated in the Association's *Manual*.

Section 2. Duties.

A. The Chair shall conduct the annual meeting and other meetings as needed and represent the Section on the Association's Executive Board. The Chair may also submit a budget to the LLA Executive Director. In addition, the Chair shall appoint a Communications Editor for the newsletter and Web Page and may appoint various other representatives and members of committees.

B. The Vice-Chair/Chair-Elect shall preside in the absence of the Chair. He/she shall serve as the Program chair for the annual conference. He/she may be required to serve on the Conference Program Committee in an ex-officio capacity. The Vice-Chair/Chair-Elect may appoint additional members to the Section's Program Planning Committee when necessary.

C. The Secretary shall record the minutes of the general membership meetings and maintain the history and bylaws of the Section. The Secretary may also serve as the Chair of the Nominating Committee for incoming officers.

Section 3. Terms of Office

Terms of office are one year with the Vice-Chair/Chair-Elect serving one year as Vice-Chair and the following year as Chair. Terms are from July 1- June 30 in accordance with the LLA *Manual* and follow the election in the spring. All officers must be members of the Section in good standing. No officer may hold more than one elected office in the Section at a time, and no officer may serve consecutive terms in the same office.

Article 5. Nominations and Elections

Section 1. A Nominating Committee of no fewer than two members, including the Chair, shall be appointed by the Section Chair.

Section 2. A slate of at least one candidate for each office, with biographical material, shall be submitted to the Executive Director, the Section Chair, the Section's Communications Editor, and the LLA Journal's Editor by Dec. 1 of that year.

Section 3. Elections shall be held by mail in conjunction with the election of other Association officers.

The Results shall be announced at the Annual Conference of the Louisiana Library Association.

Section 4. When a vacancy occurs in the Section Chair office, the Vice-Chair/Chair-Elect shall take the Chair's office to complete the expired term. He/she may also choose to complete his/her own term as well. However, if a vacancy occurs in one of the other offices, the Chair, in conference with the Executive Board, shall appoint a successor to serve until the next election.

Article 6. Representatives and Liaisons

Section 1. The Chair shall appoint a representative to the LLA Editorial Board from the Section's membership for a two year term.

Section 2. The Chair shall recommend two Section members for the LLA Tellers Committee.

Article 7. Committees and Awards

Section 1. A Nominating Committee of no fewer than two members, including the Chair, shall be appointed by the Section Chair.

Section 2. A Communications Editor for the Newsletter and Web Page shall be appointed by the Section Chair. He/she may solicit other Section members for assistance.

Section 3. The *Lucy B. Foote Award* is presented annually, if merited, to a subject specialist who has made an outstanding contribution to the library profession.

A. The Lucy B. Foote Award Committee chairperson is appointed by the Section Chair and should have at least one year's experience on this committee. Members of the committee shall be appointed by the chairperson and serve overlapping 3-year terms. These members must be current members of the Subject Specialists Section.

B. Solicitation of nominees and other committee procedures shall be carried out according to the Sections' guidelines in the LLA Manual.

C. Letters of nomination shall be forwarded to the Award winner.

Article 8. Meetings

Section 1. The annual meeting of the Subject Specialists Section shall be held during the Annual Conference of the Louisiana Library Association. Section members present at the meeting shall constitute a quorum.

Section 2. Executive Board shall meet to conduct the business of the Section when necessary.

Section 3. Other meetings may be held as deemed necessary.

Article 9. Continuing Education

The Section may conduct continuing education workshops to meet the Section's interests and/or needs on a periodic basis. These workshops may also be used to promote membership in the Section.

Article 10. Amendments

Proposed amendments to these bylaws shall be submitted to and/or initiated by the Section's Executive Board. These amendments must be publicized on the LLA Web Page and in the newsletter. Approval shall be made by a two-thirds vote of those present at the Annual Meeting.
