### Bid Law Amended

*The mission of the Trustees Section is to support members of library boards by encouraging development of effective library service and effective leadership on their boards. In the 2003 regular session, the Louisiana Legislature passed the following amendment to the Public Bid Law:

**H.B.254 by Martiny (Act 575) PUBLIC CONTRACTS/BIDS** increases the amount on purchases of materials and supplies requiring advertising and letting by contract from \$15,000 to \$20,000 and increases the amount on purchases requiring three telephone or facsimile quotations from \$7,500 or more but under \$15,000 to \$10,000 or more but under \$20,000.

### Help Needed for Trustees Scholarship

Dana Casteel won this year's Trustees Scholarship, which covers her tuition for one hour of graduate coursework at the LSU School of Library and Information Science. Any student receiving this award must plan to work as a librarian in a public library in Louisiana. In a time when it is harder to recruit new librarians with master's degrees to work in our libraries, it is imperative that we support the education of future public librarians.

At the present time there is in excess of \$8,600 in the Trustees Scholarship endowment. With cost of tuition at \$407 per semester hour and rising, it is impossible to fund the scholarship from earnings alone.

If every member of the Trustees Section would donate \$5 or \$10 annually, the total would come to \$2,000 to \$4,000. We could grow the Endowment by 50% this year and reach the goal of a self-supporting endowment within a few years. The amount of \$16,000 would generate \$480 at a rate of 3%.

### DENELLE C. WRIGHTSON, A.I.A.

Conference Presenter

Throughout her career Denelle Wrightson has specialized in the planning and design of libraries. As a recognized library design specialist her experience includes more than 60 library facilities, ranging in size from 1,000 square foot additions to design and construction of new libraries of more than 160,000 square feet. Her greater than 20 years experience, coupled with six years of employment in libraries has provided her with a unique understanding of user needs and a sensitivity to design. Recent projects include the new 100,000 square foot Southfield Library and the new Terrebonne Parish Library. She is presently working with DeSoto Parish on two new branch libraries and has signed with Lafayette Parish to work on the program for future libraries there.



### JENNIFER BLAKE

Blake has been called one of the First Ladies of romance, and the Steel Magnolia of romance fiction for her enduring career in the genre and her Southern heritage. Her initial book was published in 1970, and she became a New York Times Best Selling author in 1977 with the release of LOVE'S WILD DESIRE. Her titles have regularly appeared on this and other major lists since that time. A charter member of Romance Writers of America, Jennifer was one of the earliest recipients of the organization's Golden Treasure RITA for Lifetime Achievement and earliest inductees into the RWA Hall of Fame. She holds numerous honors from Romantic Times Magazine, is a member of the Affaire de Coeur Romance Hall of Fame, and has been awarded two silver

"Maggies" and the Holt Medallion for Outstanding Literary Talent, as well as other publishing industry citations. In 1997 she was granted the Frank Waters Award for Excellence in Writing, the first time this prestigious literary honor was presented to an author of commercial work. She has published more than 50 books, with titles released in 18 languages and an estimated 30 million copies in print worldwide.
