The Louisiana Library Association Annual Conference for 2000 will be held in Alexandria. Nancy Colyar, vice-chair/chair-elect, has put together a wonderful Academic Section program. There will be something in it for everyone.

On Wednesday, March 15, 2000, three programs will be presented. The actual titles may change, but the topics are:

1. Cataloging Titles of Aggregator Databases (Marcia Aucoin, Anne Stanton, and Sara Zimmerman, speakers).
2. Red Rover, Red Rover, Send Some GIS Right Over (John Anderson and Cindi Wolff, speakers).
3. DEED-Net (Rebecca Stenzel, speaker).

On Thursday, March 16, 2000, four programs will be presented:

4. Space Planning and Moves (Mike DiCarlo and Rebecca DiCarlo, speakers).
5. Emergency Preparedness (Elaine Smyth, speaker).
6. Joint Academic Section/ACRL-LA Business Meeting: At this meeting the Outstanding Academic Librarian Award will be presented, as well as a posthumous memorial to D. W. Schneider.
7. Dr. Wayne Brown, President of the Louisiana Community and Technical College System will speak about the new system and the information needs of its students.

On Friday, March 17, 2000, the Academic Section is co-sponsoring, with LASSAL, a speech by current ALA President Sarah Long.

We are fortunate to belong to a state with such a progressive academic library profession. The programs of interest to academic librarians in the state presented at the joint ACRL-LA/LUC meeting in Monroe, October 7-8, 1999, were outstanding, as is the new library building at the University of Louisiana at Monroe. The staff there overwhelmed us with door prizes and edible

goodies.

The new LALINC Resource Sharing Committee's Aggregator Database Cataloging Subcommittee (AD-Cat) effort will make the full-text databases so many of us rely on much more useful. Cataloging records to individual titles will become easily available to any academic institution in the state. Like previous LALINC consortial efforts, every kind of librarian from every kind of institution will collectively make bibliographic accessibility to these titles a dream come true. No one institution could do it alone. Most of all, this effort will help our library users gain better access to our rich consortial resources.

### **OUTSTANDING ACADEMIC LIBRARIAN AWARD COMMITTEE**

They will join Joe McNeill of McNeese and Martha Henderson from Northwestern. Joe McNeill will serve as the Outstanding Academic Librarian Award Committee's chair.

### **OUTSTANDING ACADEMIC LIBRARIAN AWARD**

#### **Purpose:**

To publicly recognize an individual who has made significant contributions to further the development of academic libraries/librarians/librarianship in Louisiana.

#### **Prerequisites:**

1. Must be an academic librarian currently active in his/her profession in Louisiana. On rare occasions, a non-librarian who has made exceptional contributions to academic librarianship in Louisiana may be considered.
2. Contributions must be of value to libraries or librarians as a whole and not to individual persons or institutions. Contributions, such as creating a "model library" on a particular campus, must be profound enough to be of wide interest and easily accessible for other libraries to benefit from its creation.
3. Nominations must be made by a current member of LLA and/or the Outstanding

## Academic Librarian Award Committee.

### **Evaluation Criteria:**

The award recipient is to be determined from the nomination forms and supporting data using an evaluation instrument based on a point structure.

Nominees should be characterized by one of more of the following:

1. Actively participates in/contributes to professional activities and organizations which significantly impact academic libraries.
2. Conducts research and shares this research with other Louisiana academic librarians (either through publication or through public presentation) which enhances the ability of library users to more fully utilize current information resources and technologies.
3. Serves as a model for other librarians or potential librarians; helps further the impact of Louisiana academic libraries on the education and/or livelihood of Louisiana's students and residents.

### **Nomination:**

The Outstanding Academic Librarian Award Committee shall serve as a candidate search committee accepting nominations from LLA members and/or directly nominating candidates. If a candidate is selected to receive the Outstanding Academic Librarian Award, the Committee will make its recommendation to the Academic Section Executive Committee (Chair, Vice Chair, and Secretary) for final approval.

1. Letter of nomination
  - A. Must be submitted directly to the Chair of the Award Committee.
  - B. Should include the full name, work address, telephone number, and e-mail address (if available) of the nominee.
  - C. Outline the nominee's contributions to academic librarianship.
  - D. List all special accomplishments credited to the nominee.
2. Letter/s supporting the nomination
  - A. Must be submitted directly to the Chair of the Award Committee.
  - B. Should provide further evidence that the candidate is deserving of this recognition.
  - C. The committee will compile a scrapbook of letters to be given to the award recipient the night the award is given.
3. All letters and supporting documentation for the candidates not selected become the sole property of the Outstanding Academic Librarian Award Committee. Information contained in the documents will be confidential and will be maintained for 60 days after the Conference. At that time, documents will be destroyed.

Please submit nominations as soon as possible as the nominee must be selected by December 1, 1999. Send nominations to:

## **LIBRARY NEWS**

### **LOUISIANA STATE UNIVERSITY Middleton**

The Schwing Library Lecture was held on October 28 at the Lod Cook Alumni Center. The speaker was James G. Neal, dean of University Libraries at John Hopkins University. He spoke on "The Entrepreneurial Imperative: Moving From Incremental to Radical Academic Library Development."

### **LOUISIANA STATE UNIVERSITY Eunice**

During the month of October, the library hosted an exhibit entitled "Evangeline." The exhibit included early editions of Longfellow's narrative poem, etchings duplicated from an 1879 edition of The Poetical Works of Henry Wadsworth Longfellow, which was issued in 30 parts at fifty cents each "payable on delivery," advertisements of Deloris Del Rio's 1928 silent film "Evangeline," as well as a tape of the movie itself. Also included in the exhibit was evidence of Louisiana's incorporation of the fictitious poem and its characters into everyday culture. On display were examples of the use of Evangeline in advertisements, political statements, and music.

On October 20 Dr. Claude Oubre, a scholar of Louisiana history, spoke on Evangeline and the ramifications of the 1866 poem.
